Extended Tender Notice for Insurance Companies

It is informed that a detailed Tender Notice containing all details was uploaded on the website www.bgssstrust.com on **05.12.2019** and date for submission of bids was **26.12.2019**. The date for submission of bids has been extended from **26.12.2019 to 06.01.2020** by The Bhai Ghanhya Trust being a nodal agency set up by the Government of Punjab for implementation The Bhai Ghanhya Sehat Sewa Scheme(BGSSS).

1) TENDER DOCUMENT

Since the date for submission of Tender has been extended from 26.12.2019 to 06.01.2020 therefore a Tender Document containing all the requisite details of the Scheme may be obtained by any eligible insurance company meeting the above eligibility criteria from the Manager, office of The Bhai Ghanhya Trust, SCO-175-187, Punjab State Cooperative Bank Building, Ground Floor, Sector-34-A, Near Sham Mall, Chandigarh from **27.12.2019 to 03.01.2020** on any working day between **10 am to 4 pm** by submitting a written request for the issuance of a Tender Document along with payment of a non-refundable amount of **Rs. 20,000/-** towards cost of the Tender Document in the form of a **Demand Draft in favour of “The Bhai Ghanhya Trust”, payable at Chandigarh**. The said amount shall not be refunded under any circumstances. Those Insurance Companies which have already purchased the Tender Document need not to purchase the same again.

The technical and financial bids duly signed and complete in all respects and contained in separate sealed envelopes are to be submitted in another sealed envelope (Master Envelop) with the Manager, office of The Bhai Ghanhya Trust, SCO-175-187, Punjab State Cooperative Bank Building, Ground Floor,

Sector-34-A, Near Sham Mall, Chandigarh, before **12.00 P.M on 06.01.2020**.
No bid, for whatever reasons, shall be accepted after the expiry of the above prescribed time limit.

3) OPENING TENDER

The Technical & Financial bids will be opened **at 02.30 PM on 06.01.2020** in the Committee Room of The Punjab State Cooperative Bank Ltd., SCO. No. 175-187, Sector 34-A, Chandigarh in the presence of the representatives of the bidders who so wish to attend.
